What You Can Report:

Any activity by UC or a UC employee that:

- violates University policy;
- violates a state or federal law or regulation, such as;
 - corruption
 - malfeasance
 - bribery
 - theft or misuse of government property
 - fraud
 - coercion
 - conversion;
- wastes money; or involves gross misconduct, gross incompetence, or gross inefficiency.

How To Report:

- In writing or orally
- With as much specific factual information as possible (Report what you know, but do not investigate— Leave that to the experts!)
- Anonymously, if preferred

Confidentiality will be maintained, to the extent possible.

Protection from Retaliation:

If you believe you have been retaliated against for blowing the whistle on improper activity, you may file a complaint with your supervisor, Locally Designated Official, Human Resources, or Academic Personnel.
